

TESSENDERLO GROUP: PUBLICATION OF TRANSPARENCY NOTIFICATION (ARTICLE 14, FIRST PARAGRAPH OF THE BELGIAN LAW OF MAY 2, 2007, ON THE DISCLOSURE OF SIGNIFICANT SHAREHOLDINGS)

1. SUMMARY OF THE NOTIFICATIONS

Tessenderlo Group received a transparency notification on January 14, 2025, indicating that Dimensional Fund Advisors LP was holding 646,331 voting rights of the company on January 6, 2025. They have therefore downwardly crossed the 1% statutory threshold.

Tessenderlo Group received a transparency notification on January 16, 2025, indicating that Patrick Steverlynck, Manuco International NV, Luc Tack, Oostiep Group BV and Tessenderlo Group NV were holding 80,492,647 voting rights of the company on January 6, 2025. They have therefore crossed the 75% statutory threshold.

Pursuant to voting agreements, David Booth and Rex Sinquefield, both shareholders of Dimensional Holdings Inc., have the power to appoint the majority of the directors of the entity.
